  - (ii) Copies of Registration Certificate with the CRB including copy of receipt of latest annual subscription fees paid to the Board.
  - (iii) Copies of current Business License and Registration Certificates with TRA.

- (iv) List of similar projects completed in at least the last three years giving names of employers, the consultants, project value, contract period and actual completion period and status of completion.
- (v) Projects in progress being undertaken including, type of the job, name of client and consultant, commencement and completion dates and certified letters of award for those works.
- (vi) List of equipment with detail of ownership/possession and key company personnel with their CV"s.
- (vii) Financial Capability of the firm (Current Audited Report).
- (viii) Submission of Anti-bribery policy for Code of Conduct and power of attorney.
- 5. Short listed Contractors will be contracted to apply for works by submitting Quotation(s) As and when specify and arise basis.
- 6. All applications prepared and in sealed plain envelop marked "PRE-QUALIFICATION OF LOCAL BUILDING CONTRACTORS" or "PRE-QUALIFICATION OF LOCAL CIVIL CONTRACTORS" must be submitted on Tuesday 27<sup>th</sup> June, 2017 at or before 11.00 am. Applications will be opened promptly thereafter in public and in the presence of applicants' representatives who choose to attend in the opening at the Town Council Head Quarter offices, Nzega Town.

A complete set of pre-qualification documents in English shall be submitted by interested applicants on the submission of a written application to the address above and upon payment of a nonrefundable fee of TZS. 100,000.00 (Tanzania Shillings: One Hundred thousand only) for each application.
